Safeguarding Procedures

Safeguarding is everyone's responsibility

For the purposes of this leaflet, a child, young person or vulnerable adult is referred to as a VP.

What to do if a child, young person or adult discloses information or you suspect something is wrong. Remember:

Note: ONLY TRAINED INVESTIGATORS MAY

QUESTION THE VP

- Keep calm. Reassure and do not over react
- Listen carefully and patiently
- Accept what is said without judgement
- Talk positively and reassure the person
- Do not show revulsion or distress
- Reassure the VP that they have done the right thing
- Do not promise you can keep a secret. Let the VP know that you will have to tell someone who can help.
- Do not question. Try to limit your involvement to listening or clarifying what is being said to you.
- You may ask is there anything else you would like to tell me

Whilst this may be an alarming situation to find yourself in, it is important not to let the moment pass—for every child that does finally disclose information, evidence shows that they have usually tried up to 12 times before.

Keep Yourself Safe:

- Be in view of others—do not take the VP to a hidden area
- Do not sit too near to the VP and do not touch them, even through comfort actions. e.g. an arm around their shoulder
- Keep yourself safe—the VP may interpret your interactions differently than you intended.

Next Actions:

- Record carefully what the VP has said, using their words use the Form CM1—this is on both our safeguarding boards
- Make a note of the date and time and sign your notes.
- Do not discuss the disclosure with anyone else other than the Parish Safeguarding Representative or Diocesan Safeguarding Co-Ordinator or the Police or Social Services
- Contact the Parish Safeguarding Representative immediately on the Safeguarding number.
- **If you think the VP is at immediate risk of harm, telephone the police on 999 or Social Services on 0345 603 7627 (out of hours: 0345 606 1212).**
- **If you unsure about your concerns: please telephone the Parish Safeguarding Line**

Types of Harm:

Physical: when a vulnerable person is deliberately hurt or injured.

Sexual: a vulnerable person may be forced, influenced or encouraged to take part in sexual activity. This can be physical or non-physical e.g. being made to look at inappropriate images.

Emotional: a vulnerable person may be made to feel worthless, frightened, unloved. This may be through threats, withdrawal of familiar things; shouting; seeing parents or visitors to the home fighting, or using violence.

Neglect: A vulnerable person may display a lack of care; poor hygiene; poor diet; inappropriate or inadequate clothing; lack of necessary medical attention; appropriate support.

Other Forms: Psychological; Female Genital Mutilation (FGM); Grooming; Radicalisation; Fabricated or Induced illness; Financial; On-line; Child Sexual Exploitation (CSE); Bully; Cyberbullying; Sexting;

St. Theresa of Lisieux Safeguarding Statement

St. Theresa of Lisieux is a constituent member of the Catholic Church in England and Wales. We recognise and uphold the dignity and rights of all children and vulnerable adults. We are committed to ensuring their safety and well-being. We will work with parents/carers/guardians in order to do this. We recognise each person as a gift from God. All our personnel (including clergy, religious, staff and volunteers) and parishioners have a responsibility to safeguard our children and vulnerable adult. We will support their best interests and guard against abuse. We will listen with love and compassion.

Abuse can happen to anyone regardless of gender, culture, religion, status, social background, ability.

Be alert

To assist us in being a Safe Church you can take PART in helping us keep our vulnerable members safe:

- ⇒ **Proactive:** Familiarise yourself with safeguarding through our policies, statements and even training. (you are welcome to attend).
- ⇒ **Awareness:** Be vigilant and alert to what you see or hear.
- ⇒ **Responsibility:** Looking away is not an option.
- ⇒ **Tell:** Nothing is too trivial to tell one of our safeguarders.

As a hirer or group leader you have responsibility and accountability for ensuring that children, young people and vulnerable adults are protected at all times. This means taking all reasonable steps to prevent harm, injury, illness, loss or damage occurring. VP welfare during your activity is your responsibility .
